July 29 Letter

We are writing today on behalf of the Middle Country Central School District to ask for your assistance and support as we plan for the start of school in September. Over the past year and a half, we learned a great deal as the science and best practices on controlling and mitigating the transmission of COVID evolved. We found, fairly quickly, that schools are safe centers for students and staff. It was clear that school districts are skilled at ensuring safe environments for learning. Equally clear is how responsive school districts are to guidelines and how important local control is in designing structures and responses to implementation of plans.

As a matter of fact and interest, the practices Middle Country studied and implemented throughout the past school year and this July continue to be highly effective, as evidenced by our summer programs in which pre-k through seniors are enrolled. As of this writing, we have had just one positive case and no in-district

transmissions. The importance of this piece of information is that the wearing of face masks is optional for students in summer programs and we have seen no negative impact as a result of that flexibility. Had we experienced the opposite, we would have exercised our local control over masking and required universal wearing.

Middle Country, like every other school district in New York, needs to have clear direction in regard to the protocols that will be required when our school buildings re-open for instruction on September 2, 2021, just five weeks from today. We ask that you support local control over re-opening decisions, under the guidance of the New York State Department of Health. We ask that you continue to allow us local control over whether masks are optional, as long as our positive case rates remain low. We also urge you to keep the COVID-19 vaccination as an option for students, not as a mandate.

We thank you for your consideration and support as we plan for a safe re-opening of school in September. Sincerely,

Dear Governor Hochul,

We would like to thank you for your commitment to New York State as we continue to navigate through these unprecedented times. Your very clear intent to keep our schools open was most welcomed as we share your belief that students learn best when they are in person.

The Middle Country Central School District serves about 9300 students, pre-k through grade 12. From the start of school a year ago this September, we followed re-opening guidelines very carefully, paying special attention to masking, social distancing and contact tracing, to help ensure that our schools remained safe – and open. As we shared in our July 29, 2021, letter to the Governor's office, our students and our staff have been safe in our schools. We have seen almost no spread of the virus in our schools, even with the reduced social distancing that we now have in place.

As we enter week ten of the 2021-2022 school year, we ask that you work with our local health department to provide us with clear data about how the universal mask mandate is faring in Suffolk County schools. To date, there appears to be negligible instances of classroom spread throughout Suffolk County. We also would like to know specifically what metrics we need to achieve so that we can take the next steps in returning safely to a more "normal" instructional setting, including a careful transition to the optional wearing of masks.

We would also like to express our concerns about recent conversations mandating the COVID-19 vaccination for children. The addition of the COVID-19 vaccine to the New York State required vaccination schedule for school attendance will cause many families to make difficult decisions about their children's education. It is completely understandable that parents/guardians will be hesitant to give a newly approved vaccine to their children. We believe that the decision to vaccinate children should remain a choice.

The health and well-being of our students, faculty, staff and community members is our priority. The Middle Country Central School District has carefully followed the protocol that has been set forth by both the New York State Department of Health and the Suffolk County Department of Health. Our track record is tried and

proven and has been successful in mitigating the transmission of COVID-19 within our schools both before and after vaccines.

Thank you for your consideration of these matters. We look forward to working cooperatively with you in the coming months to ensure the continuing safety of our students and staff.

Mask Mandate - Review*

Notification of Mandate: August 27, 2021: Department of Health e-mailed directive which read, in part: Effective immediately, in accordance with the Commissioner's Determination issued pursuant to 10 NYCRR 2.60, any person over the age of 2 (including all students, personnel, teachers, administrators, contractors, and visitors) must wear masks at all times indoors in P-12 school buildings, regardless of vaccination status.

Regulation 2.60 defines "Face Coverings for COVID-19 Prevention": (e) For purposes of this section face-coverings shall include, but are not limited to, cloth masks, surgical masks, and N-95 respirators that are worn to completely cover a person's nose and mouth.

Legal Basis of Mandate: The DOH is authorized by New York Public Health Law Section 201 to control and promote the control of communicable diseases. Sections 206 and 225 of that law provide broad authority to the Commissioner of Health in regard to matters of public health and the transmission of communicable diseases. Based upon those statutory provisions, the DOH is authorized to issue regulations to address public health concerns in connection with, among other things, communicable disease. New Regulation 2.60 Face Coverings for Covid 19 Prevention is premised upon those statutory provisions.

Mask Mandate - Review*

The mask mandate is law: it is fashioned as a regulation, and promulgated according to the statutory authority bestowed upon the DOH Commissioner. This is similar, in concept, to the authority of the Commissioner of Education to issue regulations pursuant to the Education Law. Districts are governed, for example, by Part 100 Regulations regarding topics such as residency determinations, DASA training, codes of conduct, APPR, and diploma requirements.

Some confusion has arisen in the field regarding the language of 2.60, which indicates individuals "may be required to cover their nose and mouth with a mask or face-covering ... in certain settings as determined by the Commissioner, which may include schools." Use of the word "may" should not be construed by districts as making masks optional, as the word "may" pertains to the authority of the DOH Commissioner to impose such a requirement, which he has now explicitly done.

To Whom Does the Mandate Apply? The language of the DOH Commissioner's directive applies to "teachers, staff, students, and visitors to P-12 schools over age two ... regardless of vaccination status." The only stated exception is for those who are unable "to medically tolerate a face covering/mask." Everyone else must comply.

Where Does It Apply? This directive does not make any specific distinction as between indoor and outdoor settings. However, reference to the "CDC recommendations for face coverings/masks in school settings" would indicate that this is limited to indoor settings, as that is the extent to which the CDC recommends masks. We recommend this mandate be implemented, effective immediately, for all indoor activities in the schools, including indoor sports, Board of Education meetings, etc, except "when eating, drinking, singing, or playing a wind instrument."

Mask Mandate - Review*

DOH Penalties: Regulation 2.60 contains a penalty provision which subjects "individuals or entities that violate this Section ... to a maximum fine of \$1000 for each violation." Reference to individuals and entities should be construed as applying to the school district, individual officers, and employees responsible for district operations, as well as parents, students, community members, and vendors who fail to abide by this regulation when at school.

State Penalties/Financial:** Total anticipated state aid for for the 2021/22 school year is \$103,076,124, which represents 38.3% of the budget. Losing state aid would require a 70.7% increase to maintain current programs from pre-k through grade 12.

District Enforcement/Students: Out of school suspension would seem to be the only appropriate disciplinary sanction for continued refusal since any other discipline would allow a student to be on school grounds without a mask. Grouping non-compliant students together (any longer than is necessary for someone to pick up the students) would be to allow a de facto exemption for the objectors and we would counsel against that. Should discipline be necessary, the usual disciplinary process must be followed, which means a suspension of up to five days can be issued by a Principal and, beyond that, a Superintendent's Hearing pursuant to Education Law Section 3214 would be required. Families that continue to send their children to school and advise their children to refuse the mask mandate, can be referred to the Department of Social Services for educational neglect.

1. PHYSICAL DISTANCING

SCDOH: Maintain at least three feet of physical distance between students within classrooms, physical education, and music. If students are engaged in singing or playing a wind instrument, at least six feet of distance between students is recommended. In physical education, ensure any contact due to activities is quick and not for extended periods of time.

When outdoors, schools should encourage activities that allow for distancing and reduced contact

District Implementation: District is implementing physical social distancing of three feet in classrooms, in most circumstances. Six feet of social distancing will be in place as appropriate. When outdoors, activities that allow for distancing and reduced contact will be encouraged.

Update - 9/13: Social distancing in cafeterias being revised to expand distancing between students as best can be done; tightest areas are in middle schools

10/13/21: Secondary Schools (Late October/November): Parent-Teacher conferences will be virtual because of the number of parents/guardians who may attend and the number of classrooms that would be opened; social distancing guidelines would not be able to be maintained.

Elementary Schools (December): Parents/guardians will be surveyed re interest in virtual or in-person conferences. In person conferences will be limited to one parent/guardian per student and masks are required.

10/25: Very small response rate to two separate surveys, but results skewed slightly towards in-person. A hybrid model will be offered for parent/teacher conferences, grades pre k - 5.

Fall/Early Winter Theatre Presentations (November and December): Drama productions will be in-person. Audience size will be limited; additional productions will be added as required by anticipated attendance. No tickets will be sold at the door; presales only. Tickets must be purchased according to advertised timelines so that seating groupings can be established (families/friends will be grouped together; spacing between groups will facilitate social distancing).

Fall/Athletic Awards (November): In-person Athletic Awards will be for Varsity Teams only; Teams will be grouped/divided into two sessions to facilitate social distancing. Each athlete may have two parent/guardians present. Face masks are required.

Overnight/Out-of-State Field Trips: Four trips are under consideration - NYSSMA (Fall/two students), Athletics (Early Spring); Music (Mid-Late Spring). Participation is optional. Parents/guardians may face loss of deposits and other costs if trips are cancelled because of COVID and/or if their child tests positive and cannot attend.

12/13/21: Masking required for all events, including meetings. Mask break practices will continue.

12/15/21: Music Events: Secondary school concerts resumed in-person; concert structures were/will be modified to limit density. Elementary concerts will resume in January.

1/12/22: Concerts scheduled for January will be moved to February (the Selden Chorus performance scheduled for Monday, 1/31/22, will stay as is); the Course Expo for next year's ninth graders will be virtual; early spring overnight athletic competitions - district participation canceled.

Approximately 8000 COVID Tests were distributed to parents/guardians of district educated students on 1/04 and 1/05. The remaining kits were distributed amongst the schools and provided to parents/guardians of students who displayed symptoms while in school. Kits were also made available for in-school use by symptomatic staff.

Updated quarantine guidance and "Test to Stay" plan presented to the Board of Education.

1/26/22: Rescheduled December/January concerts that were moved to February will take place as rescheduled.

Kits will be made available to parents/guardians to symptomatic students and staff as well individuals placed on school based quarantine.



2. MASKS

SCDOH: Mask guidance remains unchanged from the end of the prior school year in June 2021 consistent with CDC recommendations. Per existing CDC guidance, all students, staff, and visitors must wear masks indoors regardless of vaccination status. Mask wearing is not required outdoors.

District Implementation: Masking will not be required when activities are outdoors.

Indoor masking: The following structure will be evaluated regularly and, dependent upon state and/or county directives, positivity rates in the community, and positivity rates in the schools, may be revised with immediate implementation.

Masking is required in all school buildings. Mask breaks will be provided.

Visitors will have very limited access to schools and when they are in the buildings, will be required to wear masks.



3. CONTACT TRACING AND QUARANTINE

SCDOH: School districts must continue to report positive cases of COVID-19 to SCDHS. All individuals who test positive for COVID-19 must remain in isolation for 10 days from date of symptom onset or test date if asymptomatic.

Consistent with CDC guidance, students in the K-12 indoor classroom who are within at least three of an infected student with masking are excluded from the definition of close contact and not required to quarantine. SCDHS concurs with CDC guidance which recommends that fully vaccinated persons who have come into close contact with someone with suspected or confirmed COVID-19 should be tested 3-5 days after exposure.

Close contacts of positive cases of COVID-19 which do not fall in the exception detailed below must quarantine for 10 days and monitor symptoms through the 14th day. Below is the CDC exemption for K-12 students in indoor classroom setting:

Exception: In the K–12 indoor classroom setting, the close contact definition excludes students who were within three to six feet of an infected student (laboratory confirmed or a clinically compatible illness) if both students correctly and consistently wore well fitting masks the entire time.

This exception does not apply to teachers, staff, or other adults in the indoor classroom setting. It is recommended that schools continue to contact trace and notify families of potential exposure so they may monitor for symptoms closely 14 days from date of last exposure. Any students who begin to exhibit symptoms of COVID-19 should remain home and seek testing. SCDHS recommends for any activities not in the classroom – recess, lunch, support services, etc. –schools keep records of seating charts and cohort students as possible to reduce exposure and assist with contact tracing.

District Implementation: Guidance will be implemented

3. CONTACT TRACING AND QUARANTINE

SCDOH (1/05/22; 1/06/22): School districts must continue to report positive cases of COVID-19 to SCDHS. All individuals who test positive for COVID-19 must remain in isolation for 5 days from date of symptom onset if symptoms are gone or improving or test date if asymptomatic.

For students and staff who have been a close contact of a positive case and are quarantining, the quarantine period depends on vaccination status. - If the student/staff is fully vaccinated (boosted, or completed the primary series of Pfizer or Moderna vaccine within the last 6 months or completed the primary series of J&J vaccine within the last 2 months, they do NOT need to quarantine. - If the student/staff is not fully vaccinated (see above), the quarantine period has been reduced from 10 days to 5 days.

Test to Stay (Students Only): Plan presented to BOE for adoption on 1/12/22.

2/09: Three main revisions: Test to Stay now applies to in-school and out-of-school contacts; Testing table has been reduced to accommodate 5 calendar day quarantine; Participants in Test to Stay may participate in MCCSD only extracurricular activities (students and staff may not be involved in activities that include students from other school districts). Test to Stay will be implemented Monday, February 28, 2022.

District Implementation: Guidance will be implemented



4. SCHOOL DISTRICT REPORTING REQUIREMENTS

SCDOH: School districts must continue to report positive cases to SCDHS via the SCDHS portal. Only those who are required to quarantine must be reported. Those exempt from the definition of close contact(as described above and in the CDC guidance) should be informed of exposure and should be monitored closely for symptoms for 14 days from date of last exposure

District Implementation: Guidance will be implemented

5. VACCINATIONS

SCDOH: No SCDHS requirement for vaccination. Vaccination requirements for staff may be decided by the individual school districts.

District Implementation: Guidance will be implemented



SCDOH: At this time, periodic COVID-19 testing is not required by SCDHS. SCDHS will monitor community transmission and revisit if warranted. Screening testing is a prevention strategy recommended by the CDC.

District Implementation: Contacted SCDOH (via survey response) re interest to conduct testing

9/29 Update: Testing of staff is required weekly; procedures being developed in partnership with NYDOH and SCDOH. Staff who are vaccinated may opt out of weekly testing. We have applied for LSL licensing which will permit testing on site by our school nurses.

10/12: District received LSL approval; awaiting receipt of test kits. In the interim, an outside agency will be used to conduct approximately 400 tests a week.

11/10: The District received 1000 tests. In-district testing is scheduled to begin on November 29. In the interim, an outside agency will continue to test. Once in-district testing begins, students - with parent permission, will have access to testing.

12/13: District provided testing resource initiated; Student testing on Mondays; Staff testing on Thursdays. 1/10: Staff added to Monday District testing participants.

Week of 1/03: Approximately 9200 kits were provided by NYS; about 8000 kits were distributed to parents/guardians of students enrolled in district programs

Week of 1/10: Remaining kits distributed to schools; kits will be provided to symptomatic students if wanted by parents/guardians who pick up their children. Testing will also be made available to symptomatic staff. This opportunity will conclude when test supplies are exhausted.

7. TESTING RESOURCES

SCDOH: SCDHS has accepted State/Federal funding to aid schools in the establishment of COVID-19 screening testing programs to support and maintain in-person learning. SCDHS will issue a list of approved vendors schools may work with to conduct screening testing. This program is dependent upon available funding. District Implementation: Contacted SCDOH (via survey response) re interest to conduct testing



8. BUSSES

SCDOH: SCDHS concurs with existing CDC guidance that all students and adults must wear well-fitting masks while inside a bus, regardless of vaccination status.

At least three feet of physical distancing between non-household members should be maintained as much as possible on a school bus. Ventilation, loading from the rear forward, and alternate window/aisle seating can also help reduce risk of transmission.

District Implementation: Guidance will be implemented as required by DOT.

Updated Guidance: March 2, 2022

Masks are Optional

Contact Tracing will be continued so that notifications of exposures are current

Tests To Stay recommended for exposed individuals

Testing kits are available for parents, guardians, staff and community organizations
