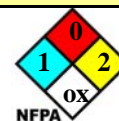

Rinse mouth with cold water. Give victim 1-2 cups of water or milk to drink. Induce vomiting immediately.**Inhalation:** Remove to fresh air. If not breathing, give artificial respiration.**Section 5: Fire Fighting Measures**Oxidizing agent.
