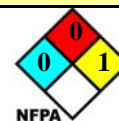
Section 3: Composition / Information on Ingredients

Ammonium Nitrate, (6484-52-2), 15-18%.

Water (7732-18-5), 82-85%.

Section 4: First Aid Measures*Always seek professional medical attention after first aid measures are provided.***Eyes:** Immediately flush eyes with excess water for 15 minutes, lifting lower and upper eyelids occasionally.**Skin:** Immediately flush skin with excess water for 15 minutes while removing contaminated clothing.**Ingestion:** Call Poison Control immediately. Rinse mouth with cold water. Give victim 1-2 cups of water or milk to drink. Induce vomiting immediately.**Inhalation:** Remove to fresh air. If not breathing, give artificial respiration.**Section 5: Fire Fighting Measures**Oxidizing agent. Noncombustible solution. When heated to decomposition, emits acrid fumes of NO_x.**Protective equipment and precautions for firefighters:** Use foam or dry chemical to extinguish fire.
