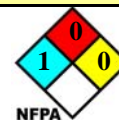

**Section 4: First Aid Measures***Always seek professional medical attention after first aid measures are provided.***Eyes:** Immediately flush eyes with excess water for 15 minutes, lifting lower and upper eyelids occasionally.**Skin:** Immediately flush skin with excess water for 15 minutes while removing contaminated clothing.**Ingestion:** Call Poison Control immediately.
