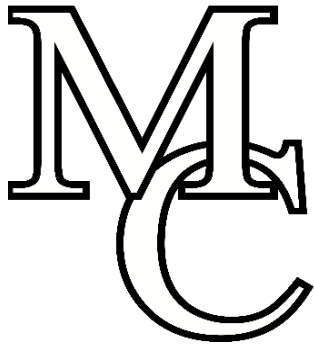

**REQUEST FOR TRANSPORTATION 2023/2024 SCHOOL YEAR**

Dear Parent/Guardian:

In accordance with N.Y.S. Education Law, residents' requests for transportation to private and parochial schools must be submitted in writing by 5:00 PM, April 1, 2022, or within 30 days of moving to the district. The purpose of the cut-off date is to enable school districts to budget funds and make the arrangements necessary to provide transportation in a reasonable and economical manner. All applications received by April 1, 2023, are guaranteed transportation for the 2023/2024 school year.

If you want transportation for your child to a private or parochial school for the 2023/2024 school year, you must file a request. Please complete the form below and return it to the Middle Country CSD Transportation Department at 25 N. Bicycle Path, Selden, NY 11784. Be sure to include an emergency contact number on your form. Requests submitted after the cut-off date will only be approved based on the available seats on the contracted or scheduled private and parochial school buses as of April 1, 2023. To ensure your child will receive transportation to a private or parochial school for the 2023/2024 school year, please file your request early.

**PLEASE NOTE:**

When a student changes schools, i.e., elementary to high school, you are required to make that change with the Middle Country CSD Central Registration office. Please call them at (631)285-8890 to make an appointment. Transportation cannot be scheduled until this is completed.
